

Delavan Lake Assembly Privacy Policy

Our privacy policy has been designed and created to ensure those affiliated with Delavan Lake Assembly of our commitment and realization of our obligation to meet most existing privacy standards.

THEREFORE, this Privacy Policy Agreement shall apply to Delavan Lake Assembly, and thus it shall govern any and all data collection and usage thereof. The following data procedures expressed within this agreement as follows:

The Delavan Lake Assembly may disclose your personal information, without prior notice to you, only if required to do so in accordance with applicable laws and/or in a good faith belief that such action is deemed necessary or is required in an effort to:

- Remain in conformance with any decrees, laws and/or statutes or in an effort to comply with any process which may be served upon Delavan Lake Assembly;
- Maintain, safeguard and/or preserve all the rights and/or property of The Delavan Lake Assembly; and

Security: Delavan Lake Assembly shall endeavor and shall take every practical precaution to maintain adequate physical, procedural and technical security with respect to our offices and information storage facilities so as to prevent any loss, misuse, unauthorized access, disclosure or modification of the user's personal information under our control.

Changes to Privacy Policy Agreement: The Delavan Lake Assembly reserves the right to update and/or change the terms of our privacy policy, and as such we will notify

the leaseholders of those changes, so that our leaseholders are always aware of the type of information we collect, how it will be used, and under what circumstances, if any, we may disclose such information. If at any point in time Delavan Lake Assembly decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Users at that time shall have the option as to whether or not to permit the use of their information in this separate manner.
